All Charge Applicants Must Complete

I/We certify that the information provided within is true and correct. I/We agree to the following terms and conditions - Payment of all invoices is net 30 days. Charges are due by the end of the month following initial charge date. After 30 days any unpaid balance will be considered past due and will be billed a finance charge at the rate of 1.5% per month (18% per annum). Balances still unpaid on the third month of billing will result in suspension of credit. In the event Jaeger Lumber shall be required to retain an attorney or bonded collection agency to collect the debt referred to herein, the customer shall pay collection fees equal to 25% of the balance due, plus court costs and expenses, in addition to amount already due to Jaeger Lumber and/or any affiliated companies. Credit Cards may be used at time of purchase only. I/We understand that credit cards will not be accepted as a form of payment on our account. I/We agree to be responsible for any purchases made by any and all representatives of myself or my company unless I notify you, in writing of any purchasing restrictions. I/We understand that the construction Lien Law requires an authorized representative on site, which is not always practical or feasible. We hereby waive the requirement of having an authorized person present when deliveries are made and agree to be responsible for such material. It is further agreed that this applicant and guarantee shall continue its liability notwithstanding any change in organization, corporate setup, or partnership change unless such change is made by way of a new and approved credit application.

### PERSONAL GUARANTEE

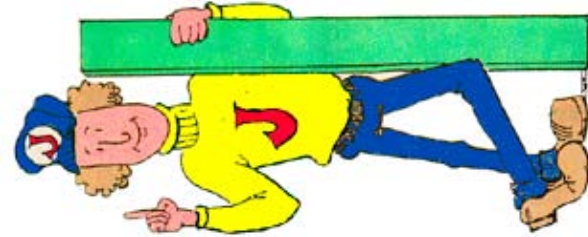
